

# ANGELQ SURVEY GIFT-CARD PROMOTION Aug2025

## OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR RECEIVE A PRIZE.**

Void where prohibited or restricted by law.

### 1. Sponsor

AngelQ AI Company, 201 Summit View Dr., Ste 250, Brentwood, TN 37027 USA ("Sponsor").

### 2. Promotion Period

Begins [ ] and ends at the earlier of (a) receipt of the first fifty (50) Qualifying Responses (defined below) or (b) **7 days after start** ("Promotion Period"). Sponsor's server clock is the official time-keeping device.

### 3. Eligibility

Open to natural persons **18 years of age or older (or the age of majority in their country of residence, whichever is higher)** who, at the time of entry, are legal residents of one of the 170 countries serviced by <https://huuray.com/> and not located in, or ordinarily resident of, any embargoed or otherwise restricted country or territory (e.g., Cuba, Iran, North Korea, Syria, Crimea, Donetsk, Luhansk). Employees, officers, and directors of Sponsor, its affiliates, and their immediate families/household members are not eligible. Promotion is **void where prohibited or restricted** by law.

### 4. How to Enter

**Qualifying Survey Entry.** During the Promotion Period, visit [survey URL], complete all required survey questions, and submit. Limit **one (1) survey submission per person/email address**. Incomplete or duplicate submissions are void.

### 5. Winner Determination & Odds

The first fifty (50) eligible entries **time-stamped by Sponsor's servers** will each be deemed a "Potential Winner," subject to verification. Odds depend solely on entry timing and the number of eligible entries received.

### 6. Prizes (50)

Each verified winner will receive **one (1) \$20 USD equivalent prepaid virtual debit card** delivered via the email address used for entry (Approximate Retail Value: US\$20 each; total ARV: US\$1,000). Gift cards are subject to the issuer's terms and conditions; issuer conversion fees may apply for non-USD transactions. Prizes are **non-transferable, non-assignable, and no cash substitution** is permitted except at Sponsor's sole discretion.

## **7. Winner Notification & Verification**

Potential Winners will be notified by email within **fourteen (14) days** after qualification. To claim a prize, each Potential Winner must follow the instructions in the notification and may be required to complete and return an **Eligibility & Liability/Publicity Release (and IRS Form W-9 for U.S. residents) within ten (10) days**. ## **11. General Conditions**

Sponsor reserves the right to cancel, suspend, or modify the Promotion if technical failure, fraud, or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion. Any attempt to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil laws and will result in disqualification.

## **12. Limitation of Liability**
